I am directed to inform that the AP State Council of Higher Education has issued notification calling for applications for Extension of Permission (EoP) from Private Unaided Degree Colleges running in leased buildings with less than 10 years of existence for the academic years 2020-21 and 2021-22 vide reference 1.

I am further directed to inform that another notification for Private Unaided Degree Colleges functioning in leased accommodation for more than 10 years for 2020-21 was issued vide reference 2. The Colleges, however have to give an undertaking on Rs.100/- stamped affidavit that they would shift to own/permanent accommodation before the commencement of academic year 2021-22.

The online applications for both categories along with guidelines are made available in the website of the Council, [apsche.org](http://apsche.org). The last date for submission of online application form without late fee is 02.06.2020 and with late fee fine is 05.06.2020.

I am further directed to inform that obtaining of EoP by Private Unaided Degree Colleges functioning in leased accommodation from the APSCHE is mandatory and the Universities are requested to insist the EoP for 2020-21 & 2021-22/2020-21 while issuing affiliation order for 2020-21.
